# Christmas Break Gunshots

Seven years ago, I got a divorce and moved into the house I currently live in. I got a good deal on it because it was what they called stigmatized property, which meant that something bad had happened in the house and the realtor had to disclose it. In the case of my house, a young boy had been accidentally shot and killed when we was playing with one of his father's handguns and it went off. It's a tragic story, but it didn't really bother me and since it was such a great price for the house. I bought it.

I was in the house for about 6-7 months and was quietly spending my first Christmas Eve there when around 10:45 pm, I hear a loud gunshot that sounded like it came from the kitchen. I should say that I own several guns and know what a gunshot sounds like. My first reaction was that someone was in my house and had fired a gun. I was in the upstairs bedroom at the time and grabbed one of my guns and got on the phone with 911. Long story short, the police showed up and there was no evidence of anyone breaking and entering or any bullet holes in any interior or exterior walls. I chalked it up to me hearing fireworks or a car backfiring outside and would have been ready to write the whole thing off had it not been for the following Christmas break.

See, nothing happened on Christmas Eve. But a few days after Christmas, I'm sitting in my living room, watching TV, when suddenly, I hear the same gunshot sound again. Once again it sounded like it came from the kitchen. The big difference was that I was only two rooms away from the kitchen, so I was positive that's where the gunshot sound came from. It was also the middle of the afternoon. I didn't call the police this time, but I made the rounds and once again, I didn't see anything out of the ordinary.

The following year, I'm having a small gathering on Christmas Day and around 8:00 pm, all 8 of us are hanging out in the living room and we all hear a gunshot from the kitchen. But again, we couldn't find anything out of the ordinary.

It went on like that every year. It was never on the same day, but once a year, between Christmas Eve and December 30<sup>th</sup>, I and anyone in the house with me at the time, would hear what sounded like gunshot coming from my kitchen. Last year, I decided to do a little research and found that the young boy who accidentally shot himself to death in my house prior to me buying it has shot himself on December 28<sup>th</sup>...in the kitchen.




## UPDATE ON INVESTIGATIONS & CONSULTATIONS

**Horrorstör: A Novel**

What would you do if you discovered your workplace is haunted? We're not talking about an office, hotel, or bar here. Instead, this novel takes place at a fictional Ikea knockoff set in Cuyahoga County, Ohio called Orsk. This ginormous place has everything you'd expect from such a store, including all the foreign-sounding furniture you could ever need and helpful staff to make sure you buy, buy, buy!

What's unusual (and what drew me to the book) is that this particular Big Box store is haunted. Every day the staff arrives to discover a number of items in the showroom rearranged, broken, or soiled; and there's nothing on the security cameras to show what happened. Out of desperation, manager Basil enlists a couple of employees—disgruntled protagonist Amy and Orsk devotee Ruth Anne—to spend the night with him in the store to try to solve the mystery.

What follows is a mashup of parody and horror that is pleasantly original. The cast of characters is a lot of fun to follow, and so is the book's format. It's written like an Orsk catalog, complete with furniture diagrams & descriptions, a map of the store, and even coupons & advertisements. (I recommend paying attention to these details because they add flavor to the story and made me laugh.) It's silly, spooky, and really an entertaining novel, well worth reading if you're in the mood for a not-so-serious ghost story.


We can't wait to see what 2022 has planned for us!
